Work Area: Underwater Robotics

Project overview: To carry out activities related to the development and implementation of robotic systems for the monitoring of the Deep Sea.

Objectives: Development of various system components, with particular emphasis on the perception system operating environmen. Development of a navigation system and control of the robotic platform, a platform supervision system and development of an operation supervision system. The work will involve the development, hardware implementation and algorithms of perception, navigation and control.
