Work Area: Data mining / Business Intelligence / Recommender Systems

Project overview: The work consists of the research and development of data mining algorithms for business intelligence and/or recommender systems, based on large amounts of data generated by the interaction of users with interactive kiosk systems.

Objectives: Development of new data mining algorithms capable of analysing data from interactive kiosks.

Academic Qualifications: Degree or Master degree in Computer Engineering, Electrical Eng., Comp. Science or related area

Minimum Profile required: Knowledge on programming and statistics

Preference factors: Previous experience/knowledge on data mining, business intelligence or recommender systems

Monthly Grant: €745,00 (Degree) or 980,00 (MSC) according to the Stipends values of the grants awarded directly by the
