Work Area: Data management workflows in Dendro with CKAN and B2Share

Project overview: Dendro is a platform for the organization and description of research data, making metadata creation easier and connecting with other Linked Open Data platforms. This work reinforces the connection of Dendro with long-time preservation platforms, using CKAN and EUDAT's B2Share as examples. Data identification is promoted with the assignments of DOI and the integration with the ORCID (http://orcid.org/) system allows the link between datasets and their creators.

Objectives: 1.Integrate Dendro with CKAN repositories at INESC TEC and U.Porto 2.Integrate Dendro with ORCID 3.Create institutional rules for DOI assignment 4.Deployment and tests of developed features with groups from project partners (INESC, InBIO, U.Porto)
