<b>Work Area:</b>	Holographic Imaging with Optical Fibres
<b>Project overview:</b>	The project aims at the laboratorial implementation of a holographic imaging system based on the use of multimode optical fibers, targeted to biological applications and small scale lensless imaging systems.
<b>Objectives:</b>	The tasks to be carried out are: - implementing efficient holographic signal processing algorithms; - performance characterization of the signal processing routines; - to supervise and assist in the definition of appropriate experimental configurations.

<b>Academic Qualifications:</b>	PhD in Applied Physics/Physics and related areas.
<b>Minimum Profile required:</b>	Good background in Optics, with strong skills in numerical modelling and signal processing. Autonomy, and good team-work capacity.
<b>Preference factors:</b>	Lab-work profile. Demonstration of previous experience within the identified minimum profile and identified project tasks.
