Project overview: The work will be developed in the context of task 3: "Implementation of e-Science platform and open data access" of the WindscannerPT infrastructure. WindscannerPT task 3 will setup the software components needed to manage the infrastructure, institutions and their equipments and researchers, to support the design and execution of open air field tests, and to support Open Access policies to deal with the collected datasets and related information

Objectives: 1. Work with the stakeholders to specify the main functionalities 2. Design and develop the set of Web services (API) 3. Develop the server-side logic to use the data server. 4. Develop the web access to the API to the management of the infrastructure and their campaigns 5. Develop web accesses to the API related to the researchers work 6. Enable the e-infrastructure to manage equipment, traceability and usages 7. Design and support an Application Profile
